



## The CPA Insurance Policy Claims Administration

### ADVICE FOR INTRODUCING BROKER

Cunningham Lindsey Construction are the appointed claims managers and will be the first point of contact for **Plant & C.A.R** claims.

### Sections 1 & 4 - Plant , Equipment & C.A.R

Notify claims/losses to the CPA Team at Cunningham Lindsey Construction **Immediately** who will deal with the claim until its final conclusion. A telephone call is the best initial approach to enable the correct action to be decided. Then follow **immediately** in writing preferably by fax or e-mail, if not then by post.

A claim form will not normally be required

### Section 2 - Employer's, Public and Products Liability

#### QBE Insurance (Europe) Limited

Notify claims/incidents to the QBE Insurance **immediately**. A telephone call is the best initial approach to enable the correct action to be decided. Then follow **immediately** in writing preferably by fax or e-mail, if not by post.

#### Royal & SunAlliance

Notify claims/incidents to the CPA Team at Cunningham Lindsey Construction **immediately**. A telephone call is the best initial approach to enable the correct action to be decided. Then follow **immediately** in writing preferably by fax or e-mail, if not by post. The CPA team will then pass your details to the Royal Sun Alliance who will send confirmation direct to you, subsequent to which you will then correspond direct with the Royal & Sun Alliance.

Claim forms are required.

### Section 3 - Motor Third Party Liability

Send initial claim forms and any correspondence the Royal & SunAlliance **as soon as possible**. Royal & SunAlliance will respond direct to you.
